  - By mailing payment to Montgomery County Treasurer, 1 Courthouse Square, Room 101, Hillsboro, IL 62049;
  - By making payment in person at the Treasurer's Office located at the Montgomery County Historic Courthouse, 1st Floor, Room 101;
  - By depositing payment in the gray metal drop box located on the North side of the Montgomery County Historic Courthouse by the fire escape.
  - By online payment at <a href="www.MontgomeryCountyIL.gov">www.MontgomeryCountyIL.gov</a>. A vendor processing fee may apply. (Note: Do not include dashes when entering the Parcel ID.)
  - By phone via IVR at (217) 627-6138. A vendor processing fee will be applied.
- 7. Mail payment stub #1 with first installment payment, payment stub #2 with second installment payment, and both payment stubs with full payment. If making a partial payment, write your Parcel ID in the memo of the check.

  Due dates are shown on each stub; see #12 & #13.
- 8. Make check payable to: Montgomery County Collector. Your cancelled check is your receipt. If you want a receipt, you must send a self-addressed, stamped envelope along with your payment.
- 9. If you pay your taxes by cash, always get a stamped receipt.
- 10. Failure of the bank to accept your check will void payment of your taxes.
- 11. If this tax bill was paid by other than addressee, please note on back of payment stub.
- 12. If your payment is late, Illinois law requires a 1.5% per month, or fraction thereof, interest penalty on each late payment.

  To avoid penalty, your tax bill must be paid on or before the due date designated on each payment stub.
- 13. A **15-Day Delinquent Notice** will be printed and mailed by Certified Mail approximately 2 weeks after the 2nd due date. For every tax bill not paid, a Delinquent Notice is mailed. **There is a \$10 preparation cost added per Delinquent Notice.**
- 14. Certain taxpayers may be eligible for:
  - The Senior Citizens and Disabled Persons Property Tax Relief and Pharmaceutical Assistance Act. Applications
    are available from the Illinois Department of Aging;
  - Abatements and/or other assistance programs. You should consult with your Township or County Assessor and/or the Illinois Department of Revenue.
